☛ Acceptance of Equipment

Category	Acceptance criteria
Preliminary acceptance before delivery	<ul style="list-style-type: none">▷ Equipment acceptance shall be subject to the agreed product processing, continuous normal operation for 2 hours, no fault, process yield $\geq 99\%$, regarded as preliminary acceptance;▷ Sign the Acceptance Report;▷ Whether the appearance of the equipment is beautiful and generous, whether the color meets the requirements, the reliability of the structure, whether the operation is convenient, whether the replacement of the wearing parts is convenient, whether the remaining parts are convenient and repairable, and whether the consistency of the technical agreement is checked;▷ The non-conforming rectification shall be carried out within a limited time as required by the demander;
Final acceptance of equipment	The final acceptance of the equipment shall be subject to the agreed products. After normal commissioning, the data of 3 shifts shall be collected continuously. If the one-time good product rate reaches $\geq 99\%$ and the average failure rate reaches $\leq 1\%$, the acceptance shall be regarded as qualified, and both parties shall immediately sign the 《Equipment Acceptance Report》 and the final acceptance of the equipment shall be completed.

☛ Responsibilities and Obligations of Both Parties

Before the equipment arrives at the site, the Demander must prepare the installation conditions for the equipment.	Within a week before delivery
4	The supplier shall complete the assembly and commissioning of the machine after the positioning of the machine, and provide training to the demander, including normal operation, maintenance, analysis of operational problems and emergency treatment procedures;	Within a mutually agreed time
5	Party B shall transport the equipment to the location designated by Party A, and both parties shall send personnel to supervise the	After delivery

6	Acceptance before delivery:The supplier shall provide the demander with the tools and testing tools required for inspection.	Initial acceptance

1	All qualified materials for test and trial production are provided free of charge	Within 10 days after signing the contract
2	Carry out daily maintenance work according to the requirements of the "Operation manual" provided by the supplier;	/
3	Participate in the review and confirmation of supplier's design scheme and experimental demonstration;	/
4	Arrange operation and maintenance personnel (referring to qualitative) to receive training from supplier;	/
5	The demander shall be equipped with necessary supporting facilities such as compressed air and power leads.	/
6	After the equipment arrives at the site, the demander shall assist in the positioning and related work of the equipment. In the process of equipment commissioning, the demander shall provide the auxiliary work required for equipment commissioning, such as material preparation and modification of related parts.	/

★After-sales Service Commitment

1	The supplier shall provide the Demander with 1-year free maintenance of the equipment (except for wearing parts) and relevant technical guidance assistance for use. During the warranty period, the supplier is responsible for free maintenance of quality problems caused by non-human reasons of the customer.	
2	In case of equipment failure during the warranty period, the supplier shall respond within 3 hours after receiving the notice from the Demander; If it is necessary to send technical personnel to the equipment site, the supplier promises to arrive at the site within 24 hours for technical service;	
3	All devices provided by the supplier strictly implement the national "three guarantees" policy. The warranty period of the equipment is 1 year (from the date of final acceptance and delivery of the equipment to Party A).Key components warranty 1 year:

4	After the final acceptance of the equipment, the supplier shall regularly call back or visit the user on the spot, and solve the problems arising in the use of the equipment;	
	After the equipment quality guarantee period, the supplier shall provide paid lifelong extensive preferential technical support and services.	

★Other Requirements:

1. Party B shall ensure that the equipment provided is original, brand new, unused, made of first-class technology and best materials, and meets the quality, specifications, type and performance requirements stipulated in the national and procurement documents;
2. This Technical Agreement shall become legal upon being signed by both parties;
3. The modification and supplement of the technical Agreement shall be subject to negotiation and signature by both parties, and both parties confirm that the modification and supplement agreement shall have the same legal effect after signature;
4. During the execution of the Technical Agreement, any dispute arising between the Parties shall be settled through negotiation in the spirit of friendly cooperation. If no settlement can be reached through negotiation, the parties shall have the right to submit the dispute to the legal authority of the place where the contract is signed for arbitration in accordance with national laws.
5. The Annex shall have the same legal effect as this Agreement.
6. The inadequacies of this Agreement shall be resolved by both parties in accordance with the principle of mutual assistance.
